ADDICTED TO TOURS TERMS AND CONDITIONS

By placing a booking with Addicted to Tours you acknowledge that you have read, understood and agree to the terms and conditions set out below.

CHARTER SERVICE BOOKING

Your Booking -

All bookings are confirmed when an email is sent by Addicted to Tours to you from the email address info@addictedtotours.com.au, a deposit amount is paid in full.

Payment -

A non-refundable booking fee of 30% is required to secure your vehicle for any charter booking: However, the remaining balance is required to be paid 10 business days prior toyour journey.

Cancellation Fees -

30% of the total booking amount if you cancel less than 10 business days prior. 50% of the total booking amount if you cancel less than 48 hours prior. 100% of the total booking amount, if you cancel less than 24 hours prior.

Adding Extra Stops -

Additional charges for extra drops are based on time and distance from the previously quoted journey. This amount is not yet known until the location of the extra stop is revealed.

Overtime Charges -

Overtime/waiting rates are charged at \$41.25 inc GST (\$165 inc GST per hour) per 15 mins (minibus/bus/coaches).

PRIVATE TOUR BOOKING

Payment -

A non-refundable booking Fee of 30% is required within 10 business days of receiving your Quote & Confirmation email to secure your private tour date. We require this as it's very important for us to schedule your venue selection as soon as possible and pay for any tastings/lunches in advance. The remaining balance is required to be paid 10 business daysprior to your tour.

Cancellation Fees -

30% of the total booking amount if you cancel less than 10 business days prior. 50% of the total booking amount if you cancel less than 48 hours prior. 100% of the total booking amount, if you cancel less than 24 hours prior.

Please Note -

The majority of our bookings are made significantly in advance of a tour date. Addicted to Tours may accept bookings on shorter notice, however if your tour date is less than 30 days away a 50% deposit must be paid within 5 business days of receiving a confirmation email. The remaining balance is required 5 business days prior to the tour date.

Any reduction in attendee numbers for group bookings will not be refunded. Tour dates cannot be changed unless discussed otherwise.

A 10% surcharge is payable for any tour taking place on a public holiday. We only accept Bank Transfer Payments.

Pick Up's & Drop Off's

You must arrive at the pick-up point nominated by Addicted to Tours 15 mins prior to the designated departure time. It is essential that tours run to schedule as wineries reserve the right to refuse a booking if a customer is late.

If you are not at the pick-up point at the designated time and miss your tour you will not be entitled to a refund.

Alcohol Consumption

Addicted to Tours & the Wineries / Venues, we attend:, do not tolerate intoxicated & disruptive behavior.

Only cans and plastic cups to be used on board, no glass bottles for safety.

Behavior

If you do not comply with a direction of an Addicted to Tours employee, the tour will be stopped immediately. Addicted to Tours will arrange for a taxi or ride sharing service to re- turn you to your pick-up location (at your expense). No refunds will be given in the event that a tour is stopped because of intoxicated or disruptive behavior.

Please note that in respect of Hens and Bucks parties, rude attire or paraphernalia cannot be taken with you into the wineries/venues we attend. Smart casual dress is required at all times.

Damage -

You will be liable for any damage caused to Addicted to Tours vehicles by you or your guests. You will be liable for the costs repair.

Cleaning/Damage Fees

If any of our vehicles/property or charters are left in an excessively dirty state or there is any illness on board. The organiser or organisation will be charged a minimum of \$300 for deep cleaning.

If a bond has been taken for a booking, it will only be returned to a customer at the conclusion of a booking and only if there is no damage to the Addicted to Tours vehicle. If damage has occurred the bond will be used to cover the cost of any repairs to the vehicle, following which any surplus will be returned to you.

Belongings -

You are fully responsible for belongings brought along on a tour/charter. Addicted to Tours takes no responsibility for lost or damage items.


Alterations to Itineraries -
